2011 Weathervane Contest Rules & Entry Form

RULES

Eligibility

Entrants must be in grades 6 through 12 or equivalent, attending public, private, or homeschooled on Nantucket during the 2011-2012 school year. Children of Nantucket Dreamland Foundation employees or judges are not eligible.

Dates

Entries must be received by the Dreamland Foundation, PO Box 989, Nantucket, MA 02554 or dropped off at their offices, 12 Oak Street, no later than 4pm Thursday, December 1, 2012.

Subject Matter

The design must be the artist's original creation and shall not be copied or duplicated from previously published art, including photographs, clip art or electronic graphic images.

Technical Requirements

Color

- Artist may use any palette they like to best display their image, however, the final image will be molded into a metal weathervane so strong, clear composition is encouraged.

Shape and Size

- The weathervane will sit on pole with the N, S, E, W directional below the final piece, so do not include that in your design, unless it helps to support your concept.

Suitability for Reproduction

The Nantucket Dreamland Foundation reserves the right to alter the design if necessary. This includes redrawing.

Submission Procedures

All entries must be mounted on an 8.5-inch by 11-inch white matte or poster board and covered by clear acetate (or plastic wrap which is secured by tape on the backside) for protection. Do not laminate the design. The **entry form** must be securely attached to the back. Each entry must be securely wrapped and mailed or hand delivered to:

Each contestant must verify that he or she meets all eligibility requirements and enclose the completed and signed entry form with a parent's or guardian's and teacher's (if applicable) signature. All designs submitted will become the sole property of the Nantucket Dreamland Foundation. The foundation will not insure any entry it receives nor assume liability for any damage, loss or theft of any entry. Each student may submit only one entry. Entries will not be returned.

Failure to Comply with Contest Rules

Any entry that fails to comply with any of the requirements of the contest shall be disqualified and will not be considered by the judging panel.

Judging of the Contest

A panel appointed by the Executive Director of the Nantucket Dreamland Foundation will serve without compensation to judge the entries. The judges will be selected to provide a representative cross-section of individuals with expertise in design, an interest in weathervanes and/or in the Dreamland Theater. Judging of the contest will take place with winners to be announced in a news release in and on the Dreamland's website by January 1, 2012.

NOTICE: Use this form to submit artwork for the Dreamland Weathervane Design Contest. Your application will not be considered unless you complete and sign this form. Personally identifiable information on this form will be used for administering the contest and to publicize winning entries.

ENTRY AGREEMENT

I, the artist, hereby enter into this agreement with the Nantucket Dreamland Foundation, hereinafter referred to as the NDF, and submit an original design to the 2012 Dreamland Weathervane design contest subject to all the following conditions.

1. **This entry is an original drawing of my own creation and is not copied or duplicated from previously published photographs, artwork or electronic graphic images.**
2. I am a registered student enrolled in grade 6-12 or equivalent at a Nantucket public or private school. I understand that no prizes other than recognition will be awarded.
3. The NDF is not liable for any damage to or for the loss of any entry submitted by an artist. Insuring the entry, if desired, is the responsibility of the artist.
4. The artwork may be copied or reproduced. Reproductions of any artwork submitted may be published or otherwise reproduced by the NDF for the distribution to others for copying and may be used for informational and educational purposes.
5. Any and all reproductions or copies of the design made or authorized by the NDF may identify the artist at the NDF's discretion.
